## Introduction Section

Due to such facts, your introduction must start with some attention-grabbing sentences. You can do so by adding a relevant quote, anecdote, or an amazing example that perfectly describes your subject or topic. Specifically, the introduction section of your analytical essay must include;

- 1. A strong hook
- 2. Brief background info that concisely describes the text or issue
- 3. Thesis statement

## **Body Section**

The body section is where your reader will expect all details and explanations about the topic or subject. Typically, your essay would comprise three (3) body paragraphs. However, do not forget that the 'number of paragraphs' may increase as per your teacher's instructions. Hence, always take care of it accordingly.

Specifically, each body paragraph should start with a sentence that sets the key point that you will cover in the paragraph. At this point, make sure to provide some analyses on the point. However, never forget to back up your analysis with the help of examples and evidence. Particularly, each paragraph of the body section of your essay must contain;

- 1. Introductory sentence
- 2. The point, the paragraph would cover
- 3. The main analysis point(s)
- 4. Example(s) and evidence(s)
- 5. Replication of example(s) and evidence(s), if needed

According to professional writers, the body section of analytical essays must contain enough details. So, make sure to ask some <u>essay writer free</u> available to write my essay if you do not have enough time to research and put all the needed details and information about the main points.

## Conclusion

Keep in mind, making any new point in the conclusion means making a critical mistake. Here, you will only need to cover the main points that you have covered in the body section. To do this with perfection, start by rephrasing the thesis statement and sum up all key points of the essay. Precisely, the following activities should complete the conclusion of your essay.

- 1. Rephrasing the thesis statement
- 2. Summary of all main points or summary of key points of analysis
- 3. Concluding Thoughts about the subject

In addition, the best way to end your essay and put a great impression on the reader can be done via adding a 'call to action'. Hence, deal with it accordingly.
